Registration and Refund Policy

Cancellation and Refund Policy Cancellation Procedure:

Cancellations are allowed at any time; however, written notification must be provided at least 14 days before the course start date if the participant cannot attend. A cancellation fee may be charged, especially if the notification is not received within the specified time frame.

Cancellation Fees:


- 60 Days or More Before Course Start Date: A penalty of 25% of the course fee will be applied.
 - 30 Days Before Course Start Date: A penalty of 50% of the course fee will be applied.
 - 14 Days or Less Before Course Start Date: No refund will be provided.


Postponements and Transfers

Course attendance can be postponed after booking with written notification required 14 days before the course start date. Transfers to another course can be made without charge if the fees for both courses are the same. LSBL reserves the right to reschedule, amend, or cancel a course or offer an alternative date. In such cases, clients may receive a full refund or credit without any liability.

Note:

- If a student is refused entry or Leave to Remain in the UK due to reasons such as lack of funds, working without a permit, poor attendance, invalid change of status, or providing false information, they will not qualify for a refund under this scheme.
- Students must book courses well in advance to meet British visa requirements. Failure to do so will disqualify them from a refund.
- Bank transfers may take up to 8 weeks, and cheques up to 10 days. College letters are issued only after bank confirmation of cleared funds.
- If a student with Leave to Remain travels outside the UK during the course or once a visa is issued and is refused re-entry, no refund will be given.
